

ORDINANCE NO. 01-12-06

BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Elkland, Tioga County, Pennsylvania, as follows:

SECTION 303, PARAGRAPH 2, thereof is amended to read as follows:

2. Sewer Rates; Residential.

First four thousand five hundred (4,500) gallons of water used, the sewer rate is forty-four (44) cents per hundred gallons with a minimum of six dollars and sixty cents (\$6.60) (1,500 gallons).

Over four thousand five hundred (4,500) gallons of water used, the rate is thirty (30) cents per hundred gallons.

The effective date for implementation of sewer rate increase is for water consumed after December 18, 2001. The first bill due date is February 20, 2002.

SECTION 103, PARAGRAPH 2, thereof is amended to read as follows:

2. Water Rates; Residential.

For all water used per month, the rate is .30 cents per hundred gallons with a minimum charge of \$4.50 (1500 gallons).

The effective date for implementation of water rate increase is for water consumed after February 18, 2001. The first bill due date is April 20, 2001.

For all of water used per month, the rate is .29 cents per hundred gallons with a minimum charge of \$4.35 (1500 gallons).


The effective date for implementation of water rate increase is for water consumed after December 18, 2000. The first bill due date is February 20, 2001.



ORDINANCE NO. 96-9-4

IT IS HEREBY ENACTED AND ORDAINED by the Borough of Elkland, Tioga County, Pennsylvania, acting through its Council, as follows:

Ordinance 93-12-2, adopted December 30, 1993, be and is hereby amended as follows: "Where more than one Consumer Unit is located in one building, house or other structure, and is served by one meter, the owner shall be treated as the consumer with respect to all consumer units located therein and the owner shall be billed and responsible for payment of all water rates, rents and charges for water service rendered by the Borough to all such consumer units."

ORDINANCE 94-2-1

BE IT ENACTED AND ORDAINED, by the Borough Council of the Borough of Elkland, Tioga County, Pennsylvania, that Ordinance No. 93-12-2 be and is hereby amended as follows:

Under "SECTION 2" "GENERAL POLICIES" the section entitled "Vacancy" be and is hereby amended to read as follows:

Regardless of whether a customer actively uses services during a monthly billing period, all buildings or units therein connected to the borough water or sewer service lines shall pay a monthly fee set at the base rate in the current year's rate schedule, except that no monthly base rate fee shall be charged during the first 30 days of any vacancy. However, no water/sewer rents above the base rate will be charged the customer if no water is used during the monthly billing period.

THIS ORDINANCE was duly enacted by the Borough Council of Elkland, Tioga County, Pennsylvania, at its regular meeting held February 8, 1994.
